- 5. **Presentation of the FY 22/23 Audit Report:** Allison Gregg from the firm of Sampson, Sampson & Patterson, LLP, presented the audit report of financial statements for the year ending June 30, 2023
- 6. **Warrant to Inspect and Abate:** A motion was made by Trustee Lockhart, seconded by Trustee Isaak, and passed by unanimous vote to approve a request to the Fresno County Superior Court for an area-wide Warrant to Inspect and Abate for use in 2024
- 7. **Ethics and Supervisor Training Requirements:** The Board reviewed training required to comply with AB 1234 and AB 1825 for Board members.
- 8. **Resolution 03 2023 UAS Authorization:** A motion was made by Trustee Isaak, seconded by Trustee Esraelian and passed by a 9-0-1 roll call vote (Hill absent) to approve and adopt Resolution 03-2023, "A Resolution of the Board of Trustees of the Consolidated Mosquito Abatement District Authorizing the Use of Unmanned Aerial Systems (UAS) for Mosquito Control and Surveillance".
- 9. **Resolution 04-2023 District Policy Updates:** A motion was made by Trustee Esraelian, seconded by Trustee Willems and passed by a 9 0 1 roll call vote (Hill absent) to approve and adopt Resolution 04-2023, ""A Resolution of the Board of Trustees of the Consolidated Mosquito Abatement District Amending Investment and Purchasing and Employee Policy Handbook Section 2000 "General", Sec. 2020 "Employment", Sec. 2060 "Vacation Leave", and Sec. 2020 "Communication Device Usage" as District Policies"".

Agenda Item 10: Professional Development Calendar Update

Background:

Pacific Southwest Center of Excellence in Vector-Borne Disease (PacVec) Annual Meeting:

At the July 2023 Board Meeting, trustees approved the District's professional development calendar for professional development events in 2023 through July 2024. The PacVec Annual Meeting has been held in California for the past seven years. However, they recently announced the 2024 Annual Meeting will be held in Phoenix, Arizona. The Board approved attendance at the PacVec meeting at a location listed in California. The original estimated cost for attendance at this meeting was \$600 per staff. The new estimate is \$900 per staff for a meeting held in Phoenix, Arizona. As stated at the July 2023 board meeting by the manager, any changes to the calendar would require approval from the board.

Vector Control Joint Powers Agency (VCJPA) Board of Directors Meetings

The VCJPA Board of Directors (BOD) meetings allow for travel reimbursement, which has regularly been requested for Trustee Taylors' participation in meetings. Trustee Taylor is currently on the BOD and has requested travel expenses to be covered by the District rather than request reimbursement from the VCJPA. The VCJPA is funded by member agencies; therefore, travel reimbursement costs are ultimately passed on to Districts. The manager recommends updating the calendar to reflect travel estimates for Trustee Taylor's participation in VCJPA meetings and for all travel expenses to be covered by the District. Travel costs are estimated at \$500-600 per meeting.

These updates would result in an overall increase in estimated travel costs of \$1500. The total estimated travel costs for 2023/2024 events remain below the budget line item for travel.

Action requested:

It is requested that the Board approve the updated professional development calendar as proposed.

Agenda Item 11: Router Upgrade and Cybersecurity services

Background: When the District constructed the new headquarters in Parlier, the network was set up by Bellwether, an IT services provider out of Fresno. In 2023, Bellwether recommended that the existing router had reached the recommended life span and should be considered for replacement in addition to upgrading security software. It was decided not to upgrade the router but to renew maintenance on the security software at that time. Given the age of the current hardware and the recommendation from Bellwether, it would be advisable to upgrade the network router and associated security software at this time.

Action requested:

The Board will be asked to approve hardware and software installation by Bellwether as listed in the enclosed Quote AAAQ2635.
